ALFUADIY has review forms to keep the same item reviewed by two reviewers. Then the editorial board makes a decision on the comments or suggestions of the reviewers.

Reviewers provide an assessment of originality, clarity of presentation, contribution to the field/science. This journal publishes research articles, articles and scientific reviews on Islamic law and comparisons in Muslim societies.
